### **Post-doc position offer**

**Social Neuroscience Lab, Institute of Psychology, PAS is looking for an individual for the post-doc position**

We are looking for a researcher for a post-doc position in a project called “*Lonely and selfish? Social decision making and loneliness - investigation with multimodal neuroimaging and experience sampling.*” funded by the National Science Centre, Poland (Grant No: 2022/46/E/HS6/00138).

The project is led by Prof. Łukasz Okruszek, the Head of Social Neuroscience Lab, Institute of Psychology, Polish Academy of Sciences, Warsaw.

Post-doc will be responsible for designing and conducting studies planned for the project, analyzing the collected data, and presenting the results. Post-doc will be employed full-time (40 hours per week).

We offer:

- 140000 PLN gross-gross per year (remuneration period - 36 months)
- no teaching duties
- a workstation and the opportunity to participate in specialized, international courses, workshops, and conferences
- a position at a young, scientifically successful, interdisciplinary research team

Requirements for candidates:

- doctoral degree in psychology, cognitive science, neuroinformatics, economics, or related science field, obtained no earlier than 7 years before the starting year of employment in the project\*, or obtained before the date of employment in the project
- documented scientific achievements (publication record in high-impact journals)
- fluency in spoken and written English
- research interests including social neuroscience and decision-making
- preferred experience in conducting studies and analyzing fMRI data
- experience in advanced statistical analysis and computational modeling of behavioral and/or physiological data with the use of R or Python will be an additional asset

Candidates should apply by attaching the following documents:

1. CV, which should include publications, grants, awards, scholarships, and fellowships, and other relevant information
2. A cover letter
3. Two recommendation letters
4. A copy of the doctoral diploma or equivalent certificate of graduation or an official documentation stating when the degree will be awarded
5. Proof of English language proficiency at level B2 or higher

The recruitment process will be carried out in two stages. During the first stage, the committee will evaluate the candidates' research achievements. The candidates with the highest final scores will be invited for an interview, which will constitute the second stage of the recruitment process.

The interviews will be scheduled between **30<sup>th</sup> and 31<sup>st</sup> July 2024** in person at the Institute of Psychology (Warsaw, Jaracza 1) or as an online interview. The recruitment results will be announced no later than **August 2<sup>nd</sup>, 2024**, and they will be published on <https://psych.pan.pl>.
